COMMITTEE ACTION

September 4, 2025

The Committee on Homeland Security met, pursuant to notice, in open markup session, a quorum being present, on September 3, 2025, at 10:00 a.m. EDT in 310 Cannon to consider the following measure:

H.R. 1736, (Mr. Pfluger) to require the Secretary of Homeland Security to conduct annual assessments on terrorism threats to the United States posed by terrorist organizations utilizing generative artificial intelligence applications, and for other purposes; the “Generative AI Terrorism Risk Assessment Act”

H.R. 2212, (Mr. Mackenzie) to amend the Homeland Security Act of 2002 to establish the Intelligence Rotational Assignment Program, and for other purposes; the “DHS Intelligence Rotational Assignment Program and Law Enforcement Support Act”

H.R. 2259, (Mr. Tony Gonzales of Texas) to amend the Homeland Security Act of 2002 to require the development of a national strategy to secure elementary and secondary schools against acts of terrorism, and ensure domestic preparedness for and the response to terrorism, and for other purposes; the “National Strategy for School Security Act of 2025”

H.R. 2261, (Mr. Hernández) to amend the Homeland Security Act of 2002 to enhance the Department of Homeland Security’s oversight of certain intelligence matters, and for other purposes; the “Strengthening Oversight of DHS Intelligence Act”

H.R. 5062, (Ms. Johnson of Texas) To amend the Implementing Recommendations of the 9/11 Commission Act of 2007 to codify the Transportation Security Administration’s responsibility relating to securing pipeline transportation and pipeline facilities against cybersecurity threats, acts of terrorism, and other nefarious acts that jeopardize the physical security or cybersecurity of pipelines, and for other purposes; the “Pipeline Security Act”

H.R. 5078, (Mr. Ogles) to amend the Homeland Security Act of 2002 to reauthorize the State and local cybersecurity grant program of the Cybersecurity and Infrastructure Security Agency of the Department of Homeland Security, and for other purposes; the “Protecting Information by Local Leaders for Agency Resilience Act” or “PILLAR Act”

H.R. 5079, (Mr. Garbarino) To reauthorize the Cybersecurity Act of 2015, and for other purposes; the “Widespread Information Management for the Welfare of Infrastructure and Government Act”
