COMMITTEE ACTION

June 25, 2026

The Committee on Homeland Security met, pursuant to notice, in open markup session, a quorum being present, on June 24, 2026, at 10:00 a.m. EDT in 310 Cannon to consider the following measure:

H.R. 3106, (Mr. Kennedy of New York) To require the Secretary of Homeland Security to conduct a collective response to a terrorism exercise that includes the management of cascading effects on critical infrastructure during times of extreme cold weather, and for other purposes; the “Weatherizing Infrastructure in the North and Terrorism Emergency Readiness Act of 2025”

H.R. 5109, (Mr. Carter of Louisiana) To require the Administrator of the Transportation Security Administration of the United States to develop guidelines to improve returning citizens' access to the Transportation Worker Identification Credential program, to assist individuals in custody of Federal, State, and local prisons in pre-applying or preparing applications for Transportation Worker Identification Credential cards, and to assist individuals requesting an appeal or waiver of preliminary determination of ineligibility, and for other purposes.

H.R. 5517, (Mr. Langworthy) To amend the Northern Border Security Review Act to require updates to the northern border threat analysis and northern border strategy, and for other purposes; the “Northern Border Security Enhancement and Review Act”

H.R. 7427, (Mr. Goldman of New York) To amend the Homeland Security Act of 2002 to provide threat analyses, including relating to terrorism threats, and guidance to State, local, Tribal, or territorial government officials or employees regarding visiting foreign nationals who seek access to State, local, Tribal, or territorial officials or employees, information, facilities, programs, or systems, and for other purposes; the “Securing Access from Foreign Entities Visiting Internal Sites in the States Act” or “SAFE VISITS Act”

H.R. 7436, (Mr. Magaziner) To amend the Homeland Security Act of 2002 to direct the Secretary of Homeland Security to implement a standardized training program for employees of the Office of Intelligence and Analysis of the Department of Homeland Security, and for other purposes; the “Department of Homeland Security Intelligence and Analysis Training Act”

H.R. 7443, (Mr. Pfluger) To amend the Homeland Security Act of 2002 to realign the mission of the Office of Intelligence and Analysis of the Department of Homeland Security, and for other purposes; the “I&A Mission Reorientation Act of 2026”

H.R. 7448, (Ms. Pou) To direct the Secretary of Homeland Security to develop a strategy to modernize the National Terrorism Advisory System, and for other purposes; the “Modernizing and Improving the National Terrorism Advisory System Act of 2026”

H.R. 7574, (Mr. Evans of Colorado) To provide for the reorganization and realignment of the Engagement, Liaison, and Outreach Office of the Department of Homeland Security, and for other purposes; the “ELO Realignment and Strategic Engagement Reform Act of 2026”

H.R. 8168, (Mr. Van Epps) To require an assessment of terrorism threats to the United States posed by foreign terrorist organizations and Specially Designated Global Terrorists present in countries that are major non-NATO allies, and for other purposes; the “Major Non-NATO Ally Terror Threat Assessment Act”

H.R. 8535, (Mr. Walkinshaw) To direct the Secretary of Homeland Security to develop performance metrics relating to the detection, deterrence, and seizure of fentanyl; the “Measuring Illicit Fentanyl Trafficking Act”

H.R. 8770, (Mr. Strong) To amend title 49, United States Code, to establish funds for investments in aviation security, and for other purposes; the “Spending Aviation Fees for Equipment, Guaranteeing Upgraded and Advanced Risk Detection and Safety Act of 2026” or “SAFEGUARDS Act of 2026”

H.R. 8874, (Mr. Carter of Louisiana) To amend the James M. Inhofe National Defense Authorization Act for Fiscal Year 2023 to require recurring reports on the transition of jurisdictions no longer eligible for Urban Area Security Initiative funding, and for other purposes; the “Homeland Security Capabilities Preservation Reporting Act of 2026”

H.R. 8897, (Mr. Mackenzie) To improve travel for American families, and for other purposes; the “Improving Travel for American Families Act”

H.R. 9327, (Mr. Joyce of Ohio) To establish in U.S. Customs and Border Protection a pilot program to adopt dogs from local animal shelters to be trained as support dogs, and for other purposes; the “Providing Emotional Assistance with Relief and Love Act” or “PEARL Act”

H.R. 9328, (Mrs. Biggs of South Carolina) To improve travel for active-duty military personnel and accompanying family, and for other purposes; the “Improving Travel for Military Members Act”

H.R. 9382, (Mr. Kennedy of New York) To require the Commissioner of U.S. Customs and Border Protection to link together applications of family members throughout the NEXUS application process, and for other purposes; the “NEXUS for Families Act”

H.R. 9388, (Mr. Gimenez) To amend title 49, United States Code, to authorize an extension of a program to permit screened passengers and their property arriving on direct flights or flight segments originating at certain foreign last point of departure airports to continue on additional flights or flight segments originating in the United States without additional screening, and for other purposes.; the “One-Stop Pilot Program Extension Act”

H.R. 9391, (Mr. Garbarino) To authorize an extension and expansion of the reimbursable screening services program of the Transportation Security Administration, and for other purposes; the “Reimbursable Screening Services Program Extension Act of 2026”

H.R. 9394, (Mr. Strong) To require the Department of Homeland Security to conduct an exercise related to agroterrorism, and for other purposes; the “Civil Preparedness for Agroterrorism Exercise Act of 2026”
