## A BILL

To establish a pilot program on home kenneling of canines  
for U.S. Customs and Border Protections Office of Field  
Operations, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “CBP Canine Home  
5       Kenneling Pilot Act”.

1 **SEC. 2. PILOT PROGRAM ON CANINE HOME KENNELING**  
2 **PROGRAM.**

3 (a) IN GENERAL.—Not later than one year after the  
4 date of the enactment of this Act, the Executive Assistant  
5 Commissioner of U.S. Customs and Border Protection’s  
6 (CBP) Office of Field Operations (OFO) shall establish  
7 a canine home kenneling pilot program (in this section re-  
8 ferred to as the “pilot program”) to assess whether canine  
9 home kenneling would benefit the OFO, including both ca-  
10 nine handlers and canines.

11 (b) GUIDANCE.—

12 (1) IN GENERAL.—Prior to establishing the  
13 pilot program, the Executive Assistant Commis-  
14 sioner shall distribute written guidance for Field Of-  
15 fices of OFO to use while implementing the pilot  
16 program.

17 (2) CONSULTATION.—In developing the guid-  
18 ance referred to in paragraph (1), the Executive As-  
19 sistant Commissioner shall consult with the following  
20 entities:

21 (A) Components of the Department of  
22 Homeland Security that utilize home kenneling.

23 (B) The Office of Health Security of the  
24 Department of Homeland Security.

25 (C) Representatives of the National Treas-  
26 ury Employees Union.

1 (c) TRAINING.—Prior to establishing the pilot pro-  
2 gram, the Executive Assistant Commissioner shall carry  
3 out the following:

4 (1) Establish training for canine handlers par-  
5 ticipating in the pilot program to take full responsi-  
6 bility of a canine's daily care, including feeding, ex-  
7 ercise, and medical needs.

8 (2) Disseminate best practices for the integra-  
9 tion of a working canine into the canine handler's  
10 residence.

11 (d) REQUIREMENTS.—In carrying out the pilot pro-  
12 gram, the Executive Assistant Commissioner shall carry  
13 out the following:

14 (1) Ensure that not fewer than ten ports of  
15 entry participate in the pilot program.

16 (2) Ensure that canines assigned to seaports,  
17 airports, and land ports of entry in both urban and  
18 rural locations participate in the pilot program.

19 (3) Provide for the participation of canine han-  
20 dlers on a voluntary basis.

21 (4) Continue the pilot program for a period of  
22 not less than two years.

23 (5) Terminate the pilot program not more than  
24 three years after the establishment of the pilot pro-  
25 gram.

1 (e) BRIEFING AND REPORT TO CONGRESS.—

2 (1) BRIEFING.—Not later than one year after  
3 the date of the enactment of this Act, the Executive  
4 Assistant Commissioner shall provide to the appro-  
5 priate congressional committees a briefing describing  
6 the guidance, training, and requirements for the  
7 pilot program.

8 (2) REPORT.—Not later than 180 days after  
9 the termination of the pilot program, the Executive  
10 Assistant Commissioner shall submit to the appro-  
11 priate congressional committees a report that in-  
12 cludes the following:

13 (A) Information relating to the number  
14 and location of participating canine teams.

15 (B) Findings of the pilot program, includ-  
16 ing a cost-benefit, job performance, health, and  
17 wellbeing analysis comparing use of home  
18 kenneling with centralized kenneling practices.

19 (C) Recommendations regarding the con-  
20 tinued use of home kenneling for CBP Office of  
21 Field Operations.

22 (f) DEFINITIONS.—In this section:

23 (1) APPROPRIATE CONGRESSIONAL COMMIT-  
24 TEES.—The term “appropriate congressional com-  
25 mittees” means—

1 (A) the Committee on Homeland Security  
2 in the House of Representatives; and

3 (B) the Committee on Homeland Security  
4 and Governmental Affairs in the Senate.

5 (2) HOME KENNELING.—The term “home  
6 kenneling” means the practice whereby canines used  
7 for Federal law enforcement purposes are housed  
8 and cared for at the residences of their assigned  
9 handlers instead of a centralized facility owned or  
10 contracted by a Federal agency.
