1 Be it enacted by the Senate and House of Representa-		
2 tives of the United States of America in Congress assembled,		
3 SECTION 1. SHORT TITLE.		
4 This Act may be cited as the "DHS Medical Counter-		
5 measures Act".		

1 SEC. 2. MEDICAL COUNTERMEASURES PROGRAM.

2 (a) In General.—Subtitle C of title XIX of the 3 Homeland Security Act of 2002 (6 U.S.C. 311 et seq.) is amended by adding at the end the following new section: 4 5 "SEC. 1932. MEDICAL COUNTERMEASURES. 6 "(a) IN GENERAL.—The Secretary shall establish a 7 medical countermeasures program to facilitate personnel 8 readiness, and protection for the Department's employees 9 and working animals in the event of a chemical, biological, radiological, nuclear, or explosives attack, naturally occur-10 11 ring disease outbreak, or pandemic, and to support De-12 partment mission continuity. 13 "(b) Oversight.—The Chief Medical Officer of the Department shall provide programmatic oversight of the 15 medical countermeasures program established pursuant to 16 subsection (a), and shall— 17 "(1) develop Department-wide standards for 18 countermeasure medical security. disstorage, 19 pensing, and documentation; 20 "(2) maintain a stockpile of medical counter-21 measures, including antibiotics, antivirals, and radio-22 logical countermeasures, as appropriate; 23 "(3) preposition appropriate medical counter-24 measures in strategic locations nationwide, based on 25 threat and employee density, in accordance with ap-26 plicable Federal statutes and regulations;

1	"(4) provide oversight and guidance regarding
2	the dispensing of stockpiled medical counter-
3	measures;
4	"(5) ensure rapid deployment and dispensing of
5	medical countermeasures in a chemical, biological,
6	radiological, nuclear, or explosives attack, naturally
7	occurring disease outbreak, or pandemic;
8	"(6) provide training to Department employees
9	on medical countermeasure dispensing; and
10	"(7) support dispensing exercises.
11	"(c) Medical Countermeasures Working
12	GROUP.—The Chief Medical Officer shall establish a med-
13	ical countermeasures working group comprised of rep-
14	resentatives from appropriate components and offices of
15	the Department to ensure that medical countermeasures
16	standards are maintained and guidance is consistent.
17	"(d) Medical Countermeasures Manage-
18	MENT.—Not later than 120 days after the date of the en-
19	actment of this section, the Chief Medical Officer shall de-
20	velop and submit to the Secretary an integrated logistics
21	support plan for medical countermeasures, including—
22	"(1) a methodology for determining the ideal
23	types and quantities of medical countermeasures to
24	stockpile and how frequently such methodology shall
25	be reevaluated:

1	"(2) a replenishment plan; and
2	"(3) inventory tracking, reporting, and rec-
3	onciliation procedures for existing stockpiles and
4	new medical countermeasure purchases.
5	"(e) Stockpile Elements.—In determining the
6	types and quantities of medical countermeasures to stock-
7	pile under subsection (d), the Chief Medical Officer shall
8	utilize, if available—
9	"(1) Department chemical, biological, radio-
10	logical, and nuclear risk assessments; and
11	"(2) Centers for Disease Control and Preven-
12	tion guidance on medical countermeasures.
13	"(f) Report.—Not later than 180 days after the
14	date of the enactment of this section, the Secretary shall
15	submit to the Committee on Homeland Security of the
16	House of Representatives and the Committee on Home-
17	land Security and Governmental Affairs of the Senate the
18	plan developed in accordance with subsection (d) and brief
19	such Committees regarding implementing the require-
20	ments of this section.
21	"(g) Definition.—In this section, the term 'medical
22	countermeasures' means antibiotics, antivirals, radio-
23	logical countermeasures, and other countermeasures that
24	may be deployed to protect the Department's employees
25	and working animals in the event of a chemical, biological,

- 1 radiological, nuclear, or explosives attack, naturally occur-
- 2 ring disease outbreak, or pandemic.".
- 3 (b) CLERICAL AMENDMENT.—The table of contents
- 4 in section 1(b) of the Homeland Security Act of 2002 is

- 6 the following new item:
