OFFERED BY MR. GREEN OF TENNESSEE

**(Providing for reconciliation pursuant to H. Con. Res. 14, the
Concurrent Resolution on the Budget for Fiscal Year 2025)**

Strike “**Title IV—COMMITTEE ON HOME-
LAND SECURITY**” and all that follows through “(4)
\$450,000,000, to remain available until September 30,
2029, for the Operation Stonegarden Grant Program.”
and insert the following:

1 **TITLE VI—COMMITTEE ON**
2 **HOMELAND SECURITY**
3 **SEC. 60001. BORDER BARRIER SYSTEM CONSTRUCTION,**
4 **INVASIVE SPECIES, AND BORDER SECURITY**
5 **FACILITIES IMPROVEMENTS.**

6 In addition to amounts otherwise available, there is
7 appropriated to the Commissioner of U.S. Customs and
8 Border Protection for fiscal year 2025, out of any money
9 in the Treasury not otherwise appropriated, to remain
10 available until September 30, 2029, the following:

11 (1) \$46,500,000,000 for necessary expenses re-
12 lating to the following:

1 (A) Construction, installation, or improve-
2 ment of primary, waterborne, and secondary
3 barriers.

4 (B) Access roads.

5 (C) Barrier system attributes, including
6 cameras, lights, sensors, roads, and other detec-
7 tion technology.

8 (2) \$50,000,000 for necessary expenses relating
9 to eradication and removal of the carrizo cane plant,
10 salt cedar, or any other invasive plant species that
11 impedes border security operations along the Rio
12 Grande River.

13 (3) \$5,000,000,000 for necessary expenses re-
14 lating to lease, acquisition, construction, or improve-
15 ment of U.S. Customs and Border Protection facili-
16 ties and checkpoints in the vicinity of the southwest,
17 northern, and maritime borders.

18 **SEC. 60002. U.S. CUSTOMS AND BORDER PROTECTION PER-**
19 **SONNEL AND FLEET VEHICLES.**

20 (a) CBP PERSONNEL.—In addition to amounts oth-
21 erwise available, there is appropriated to the Commis-
22 sioner of U.S. Customs and Border Protection for fiscal
23 year 2025, out of any money in the Treasury not otherwise
24 appropriated, \$4,100,000,000, to remain available until
25 September 30, 2029, to hire and train additional Border

1 Patrol agents, Office of Field Operations Officers, Air and
2 Marine agents, rehired annuitants, and U.S. Customs and
3 Border Protection support personnel.

4 (b) RESTRICTIONS.—None of the funds made avail-
5 able by subsection (a) may be used to recruit, hire, or train
6 personnel for the duties of processing coordinators.

7 (c) CBP RETENTION AND HIRING BONUSES.—In ad-
8 dition to amounts otherwise available, there is appro-
9 priated to the Commissioner of U.S. Customs and Border
10 Protection for fiscal year 2025, out of any money in the
11 Treasury not otherwise appropriated, \$2,052,630,000, to
12 remain available until September 30, 2029, to provide an-
13 nual retention bonuses or signing bonuses to eligible Bor-
14 der Patrol agents, Office of Field Operations Officers, and
15 Air and Marine agents.

16 (d) CBP VEHICLES.—In addition to amounts other-
17 wise available, there is appropriated to the Commissioner
18 of U.S. Customs and Border Protection for fiscal year
19 2025, out of any money in the Treasury not otherwise ap-
20 propriated, \$813,000,000, to remain available until Sep-
21 tember 30, 2029, for the lease or acquisition of additional
22 marked patrol units.

23 (e) FLETC.—In addition to amounts otherwise avail-
24 able, there is appropriated to the Director of the Federal
25 Law Enforcement Training Center for fiscal year 2025,

1 out of any money in the Treasury not otherwise appro-
2 priated—

3 (1) \$285,000,000, to remain available until
4 September 30, 2029, to support the training of
5 newly hired Federal law enforcement personnel em-
6 ployed by the Department of Homeland Security;
7 and

8 (2) \$465,000,000, to remain available until
9 September 30, 2029, for procurement and construc-
10 tion, improvements, and related expenses of the Fed-
11 eral Law Enforcement Training Centers facilities.

12 (f) BORDER SECURITY WORKFORCE RECRUITMENT
13 AND APPLICANT SOURCING.—In addition to amounts oth-
14 erwise available, there is appropriated to the Commis-
15 sioner of U.S. Customs and Border Protection for fiscal
16 year 2025, out of any money in the Treasury not otherwise
17 appropriated, \$600,000,000, to remain available until
18 September 30, 2029, for marketing, recruiting, applicant
19 sourcing and vetting, and operational mobility programs
20 for border security personnel.

1 **SEC. 60003. U.S. CUSTOMS AND BORDER PROTECTION**
2 **TECHNOLOGY, NATIONAL VETTING CENTER,**
3 **AND OTHER EFFORTS TO ENHANCE BORDER**
4 **SECURITY.**

5 (a) CBP TECHNOLOGY.—In addition to amounts oth-
6 erwise available, there is appropriated to the Commis-
7 sioner of U.S. Customs and Border Protection for fiscal
8 year 2025, out of any money in the Treasury not otherwise
9 appropriated, to remain available until September 30,
10 2029, the following:

11 (1) \$1,076,317,000 for necessary expenses re-
12 lating to procurement and integration of new non-in-
13 trusive inspection equipment and associated civil
14 works, artificial intelligence, integration, and ma-
15 chine learning, as well as other mission support, to
16 combat the entry of illicit narcotics along the south-
17 west, northern, and maritime borders.

18 (2) \$2,766,000,000 for necessary expenses re-
19 lating to upgrades and procurement of border sur-
20 veillance technologies along the southwest, northern,
21 and maritime borders.

22 (3) \$673,000,000 for necessary expenses, in-
23 cluding the deployment of technology, relating to the
24 biometric entry and exit system under section 7208
25 of the Intelligence Reform and Terrorism Prevention
26 Act of 2004 (8 U.S.C. 1365b).

1 (b) RESTRICTIONS.—None of the funds made avail-
2 able pursuant to subsection (a)(2) may be used for the
3 procurement or deployment of surveillance towers that
4 have not been—

5 (1) tested, and

6 (2) accepted,

7 by the Federal Government to deliver autonomous capa-
8 bilities.

9 (c) AIR AND MARINE OPERATIONS.—In addition to
10 amounts otherwise available, there is appropriated to the
11 Commissioner of U.S. Customs and Border Protection for
12 fiscal year 2025, out of any money in the Treasury not
13 otherwise appropriated, \$1,234,000,000, to remain avail-
14 able until September 30, 2029, for Air and Marine Oper-
15 ations' upgrading and procurement of new platforms for
16 rapid air and marine response capabilities.

17 (d) NATIONAL VETTING CENTER.—In addition to
18 amounts otherwise available, there is appropriated to the
19 Commissioner of U.S. Customs and Border Protection for
20 fiscal year 2025, out of any money in the Treasury not
21 otherwise appropriated, \$16,000,000, to remain available
22 until September 30, 2029, for necessary expenses relating
23 to U.S. Customs and Border Protection's National Vetting
24 Center to support screening, vetting activities, and expan-
25 sion of the criminal history database of foreign nationals.

1 (e) OTHER EFFORTS TO COMBAT DRUG TRAF-
2 FICKING TO ENHANCE BORDER SECURITY.—In addition
3 to amounts otherwise available, there is appropriated to
4 the Secretary of Homeland Security for fiscal year 2025,
5 out of any money in the Treasury not otherwise appro-
6 priated, \$500,000,000, to remain available until Sep-
7 tember 30, 2029, for enhancing border security and com-
8 batting trafficking, including fentanyl and its precursor
9 chemicals, at the southwest, northern, and maritime bor-
10 ders.

11 (f) COMMEMORATIONS.—In addition to amounts oth-
12 erwise available, there is appropriated to the Secretary of
13 Homeland Security for fiscal year 2025, out of any money
14 in the Treasury not otherwise appropriated, \$1,000,000,
15 to remain available until September 30, 2029, for com-
16 memorating efforts and events related to border security.

17 (g) DEFINITION.—In this section, the term “autono-
18 mous” means integrated software and hardware systems
19 that utilize sensors, onboard computing, and artificial in-
20 telligence to identify items of interest that would otherwise
21 be manually identified by U.S. Customs and Border Pro-
22 tection personnel.

1 **SEC. 60004. STATE AND LOCAL LAW ENFORCEMENT PRESI-**
2 **DENTIAL RESIDENCE PROTECTION.**

3 (a) PRESIDENTIAL RESIDENCE PROTECTION.—In
4 addition to amounts otherwise available, there is appro-
5 priated to the Administrator of the Federal Emergency
6 Management Agency, for fiscal year 2025, out of any
7 money in the Treasury not otherwise appropriated,
8 \$300,000,000, to remain available until September 30,
9 2029, for the reimbursement of extraordinary law enforce-
10 ment personnel costs for protection activities directly and
11 demonstrably associated with any residence of the Presi-
12 dent that is designated pursuant to section 3 of the Presi-
13 dential Protection Assistance Act of 1976 (Public Law
14 94–524) to be secured by the United States Secret Serv-
15 ice.

16 (b) AVAILABILITY.—Funds under subsection (a) shall
17 be available only for costs that a State or local agency—

18 (1) incurred or incurs on or after July 1, 2024;

19 (2) can demonstrate to the Administrator of the
20 Federal Emergency Management Agency as being—

21 (A) in excess of the costs of normal and
22 typical law enforcement operations;

23 (B) directly attributable to the provision of
24 protection described in such subsection; and

25 (C) associated with a non-governmental
26 property designated pursuant to section 3 of

1 the Presidential Protection Assistance Act of
2 1976 (Public Law 94–524) to be secured by the
3 United States Secret Service; and

4 (3) certifies to the Administrator as being for
5 protection activities requested by the Director of the
6 United States Secret Service.

7 **SEC. 60005. STATE HOMELAND SECURITY GRANT PRO-**
8 **GRAM.**

9 In addition to amounts otherwise available, there is
10 appropriated to the Administrator of the Federal Emer-
11 gency Management Agency, for fiscal year 2025, out of
12 any money in the Treasury, not otherwise appropriated,
13 to be administered under the State Homeland Security
14 Grant Program authorized under section 2004 of the
15 Homeland Security Act of 2002 (6 U.S.C. 605), to en-
16 hance State, local, and Tribal security through grants,
17 contracts, cooperative agreements, and other activities, of
18 which—

19 (1) \$500,000,000, to remain available until
20 September 30, 2029, for State and local capabilities
21 to detect, identify, track, or monitor threats from
22 unmanned aircraft systems (as such term is defined
23 in section 44801 of title 49, United States Code);

1 (2) \$625,000,000, to remain available until
2 September 30, 2029, for security, planning, and
3 other costs related to the 2026 FIFA World Cup;

4 (3) \$1,000,000,000, to remain available until
5 September 30, 2029, for security, planning, and
6 other costs related to the 2028 Olympics; and

7 (4) \$450,000,000, to remain available until
8 September 30, 2029, for the Operation Stonegarden
9 Grant Program.
