## **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Department of Home5 land Security Intelligence and Cybersecurity Diversity
6 Fellowship Program Act".

"(4) INSTITUTION OF HIGHER EDUCATION.—
 The term 'institution of higher education' has the
 meaning given that term in section 101 of the High er Education Act of 1965 (20 U.S.C. 1001).

5 "(5) MINORITY-SERVING INSTITUTION.—The
6 term 'minority-serving institution' means an institu7 tion of higher education described in section 371(a)
8 of the Higher Education Act of 1965 (20 U.S.C.
9 1067q(a)).

10 "(b) PROGRAM.—The Secretary shall carry out an in11 telligence and cybersecurity diversity fellowship program
12 (in this section referred to as the 'Program') under which
13 an eligible individual may—

14 "(1) participate in a paid internship at the De15 partment that relates to intelligence, cybersecurity,
16 or a combination thereof;

17 "(2) receive tuition assistance from the Sec-18 retary; and

"(3) upon graduation from an institution of
higher education and successful completion of the
Program (as defined by the Secretary), receive an
offer of employment to work in an intelligence or cybersecurity position of the Department that is in the
excepted service.

"(c) ELIGIBILITY.—To be eligible to participate in
 the Program, an individual shall—
