A BILL

To provide PreCheck to certain severely injured or disabled veterans, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Veterans Expedited
3 TSA Screening Safe Travel Act” or the “VETS Safe
4 Travel Act”.

5 **SEC. 2. AVAILABILITY OF PRECHECK PROGRAM TO CER-**

6 **TAIN SEVERELY INJURED OR DISABLED VET-**
7 **ERANS.**

8 (a) **IN GENERAL.**—Section 44927 of title 49, United
9 States Code, is amended by adding at the end the fol-
10 lowing:

11 “(g) **AVAILABILITY OF PRECHECK PROGRAM TO**
12 **CERTAIN SEVERELY INJURED OR DISABLED VET-**
13 **ERANS.**—

14 “(1) **IN GENERAL.**—A veteran described in
15 paragraph (2) is eligible for security screening under
16 the PreCheck Program under section 44919 at no
17 cost to the veteran if the veteran is able to meet the
18 background check and other security requirements
19 for participation in the program.

20 “(2) **VETERANS DESCRIBED.**—A veteran de-
21 scribed in this paragraph is a veteran who—

22 “(A) is enrolled in the patient enrollment
23 system of the Department of Veterans Affairs
24 established and operated under section 1705 of
25 title 38, United States Code;

26 “(B) has—

1 “(i) lost, or lost use of, a limb;
2 “(ii) become paralyzed or partially
3 paralyzed; or
4 “(iii) incurred permanent blindness;
5 and
6 “(C) as a result of a loss, paralyzation or
7 partial paralyzation, or blindness described in
8 subparagraph (B), requires the use of a wheel-
9 chair, prosthetic limb, or other assistive device
10 to aid with mobility.”.

11 (b) COORDINATION ON IMPLEMENTATION.—The Ad-
12 ministrator of the Transportation Security Administration
13 and the Secretary of Veterans Affairs shall jointly—
14 (1) develop and implement a process under
15 which a veteran described in paragraph (2) of sub-
16 section (g) of section 44927 of title 49, United
17 States Code, as added by subsection (a), can receive
18 the benefits under such subsection by not later than
19 one year after the date of enactment of this Act; and
20 (2) provide to Congress a briefing on the status
21 of implementing the process required by paragraph
22 (1) by not later than one year after the date of the
23 enactment of this Act.

1 **SEC. 3. OUTREACH FOR DISABLED VETERANS ON AVAIL-**

2 **ABILITY OF TRANSPORTATION SECURITY AD-**

3 **MINISTRATION PROGRAMS.**

4 (a) COORDINATION.—The Secretary of Veterans Af-
5 fairs and the Administrator of the Transportation Secu-
6 rity Administration shall develop and implement a process
7 under which the Secretary provides to disabled veterans
8 effective outreach about Transportation Security Adminis-
9 tration programs designed to improve the screening proc-
10 ess for passengers with disabilities.

11 (b) FURTHER ENHANCEMENTS TO EASE AIR TRAV-
12 EL FOR WOUNDED WARRIOR AND OTHER DISABLED
13 VETERANS.—Notwithstanding section 3501 et seq. of title
14 44, United States Code (commonly referred to as the “Pa-
15 perwork Reduction Act”), or any other provision of law,
16 the Secretary of Veterans Affairs, in coordination with the
17 Administrator of the Transportation Security Administra-
18 tion, shall—

19 (1) engage appropriate veterans service organi-
20 zations and other relevant organizations, as appro-
21 priate, to assess the awareness of veterans of rel-
22 evant Transportation Security Administration pro-
23 grams; and

24 (2) examine the need and feasibility of other
25 measures to improve travel security procedures for
26 disabled veterans.

1 (c) BRIEFING REQUIREMENT.—Not later than 180
2 days after the date of the enactment of this Act, the Sec-
3 retary of Veterans Affairs and the Administrator of
4 Transportation Security Administration shall jointly pro-
5 vide to Congress a briefing on the status of the implemen-
6 tation of subsections (a) and (b).
