Dear Acting Secretary Wolf and Secretary Azar:

We write with concern regarding the Trump Administration's indefinite extension of certain border restrictions, which affect all of our nation's borders, during the coronavirus epidemic.

On March 20, 2020, the CDC issued an Order suspending the introduction of persons who would need to be held in congregate settings at ports of entry or Border Patrol stations at or near the U.S. borders with Mexico or Canada.<sup>2</sup> We continue to have concerns about the legality and public health justification of this Order,<sup>3</sup> which was previously subject to review and public justification every 30 days if extended.<sup>4</sup> We also have concerns regarding whether the protections and screenings for asylum seekers are being provided as guaranteed under U.S. and international law.

The Order has already resulted in the expulsion of over 20,000 migrants to Mexico or their home countries,5 including the unconscionable expulsion of over 900 unaccompanied children6 without the screenings and due process guaranteed to them by law.7 In addition, U.S. asylum programs are barely operating. Since March 21, 2020, Border Patrol agents have referred just 59 migrants who expressed fear of torture to U.S. Citizenship and Immigration Services officers, and only two of these migrants have been granted protection.8 In comparison, immigration courts granted asylum to 13,248 individuals in 2018.9

The Administration must not use the coronavirus pandemic as cover to pursue anti-immigrant policies. Restrictions imposed during this pandemic should be properly targeted and limited. Imposing indefinite border restrictions is not an appropriate response to the current crisis and appears to conflict or run contrary to the law. We urge you to terminate the indefinite Order and implement only those measures necessary to protect public health.
