A BILL

To amend the Homeland Security Act of 2002 relating to the responsibilities and functions of Chief Privacy Officer of the Department of Homeland Security, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Privacy Office En-
5 hancement Act”.

1 **SEC. 2. RESPONSIBILITIES AND FUNCTIONS OF CHIEF PRI-**
2 **VACY OFFICER.**

3 (a) IN GENERAL.—Section 222 of the Homeland Se-
4 curity Act of 2002 (6 U.S.C. 142) is amended—

5 (1) in subsection (a)—

6 (A) in the matter preceding paragraph

7 (1)—

8 (i) by inserting “to be the Chief Pri-
9 vacy Officer of the Department,” after “in
10 the Department,”; and

11 (ii) by striking “to the Secretary, to
12 assume” and inserting “to the Secretary.
13 Such official shall have”;

14 (B) in paragraph (5)(B), by striking
15 “and” at the end; and

16 (C) by striking paragraph (6) and insert-
17 ing the following new paragraphs:

18 “(6) developing guidance to assist components
19 of the Department in developing privacy policies and
20 practices;

21 “(7) establishing a mechanism to ensure such
22 components are in compliance with Federal, regu-
23 latory, statutory, and Department privacy require-
24 ments, mandates, directives, and policies;

25 “(8) working with the Chief Information Officer
26 of the Department to identify methods for managing

1 and overseeing the records, management policies,
2 and procedures of the Department;

3 “(9) working with components and offices of
4 the Department to ensure that information sharing
5 activities incorporate privacy protections;

6 “(10) serving as the Chief FOIA Officer of the
7 Department for purposes of subsection (j) of section
8 552 of title 5, United States Code (popularly known
9 as the Freedom of Information Act), to manage and
10 process requests related to such section;

11 “(11) developing guidance on procedures to be
12 followed by individuals making requests for informa-
13 tion under such section 552;

14 “(12) overseeing the management and proc-
15 essing of requests for information under such section
16 552 within Department Headquarters and relevant
17 Department component offices;

18 “(13) providing component heads with input on
19 the management of their respective FOIA offices, in-
20 cluding recruiting and hiring component FOIA offi-
21 cers, budget formulation, and organizational place-
22 ment within each such component;

23 “(14) identifying and eliminating unnecessary
24 and duplicative actions taken by the Department in

1 the course of processing requests for information
2 under such section 552;

3 “(15) preparing an annual report to Congress
4 that includes—

5 “(A) a description of the activities of the
6 Department that affect privacy during the fiscal
7 year covered by the report, including complaints
8 of privacy violations, implementation of section
9 552a of title 5, United States Code (popularly
10 known as the Privacy Act of 1974), internal
11 controls, and other matters; and

12 “(B) the number of new technology pro-
13 grams implemented in the Department during
14 the fiscal year covered by the report, the num-
15 ber of such programs that the Chief Privacy Of-
16 ficer has evaluated to ensure that privacy pro-
17 tections are considered and implemented, the
18 number of such programs that effectively imple-
19 mented privacy protections into new technology
20 programs, and an explanation of why any new
21 programs did not effectively implement privacy
22 protections; and

23 “(16) carrying out such other responsibilities as
24 the Secretary determines are appropriate, consistent
25 with this section.”; and

1 (2) by adding at the end the following new sub-
2 section:

3 “(f) REASSIGNMENT OF FUNCTIONS.—Notwith-
4 standing subsection (a)(10), the Secretary may reassign
5 the functions related to managing and processing requests
6 for information under section 552 of title 5, United States
7 Code, to another officer within the Department, consistent
8 with requirements of such section.”.
