# RESOLUTION

Directing the Secretary of Homeland Security to transmit to the House of Representatives certain documents relating to Department of Homeland Security policies and activities related to domestic preparedness and collective response to terrorism and the Department's cybersecurity activities.

1       *Resolved*, That not later than 14 days after the date  
2 of the adoption of this resolution, the Secretary of Home-  
3 land Security is directed to transmit to the House of Rep-  
4 resentatives copies of any documentation, including any

1 document, record, memo, correspondence, or other com-  
2 munication, or any portion of any such documentation, of  
3 the Department of Homeland Security relating to domes-  
4 tic preparedness and collective response to terrorism and  
5 the Department's cybersecurity activities, to the extent  
6 such documentation or any portion thereof is in the pos-  
7 session of the Secretary, that refers or relates to the fol-  
8 lowing:

9           (1) Any documentation related to any pause of  
10 Department grants, loans, or other financial assist-  
11 ance contemplated or ordered on or after January  
12 20, 2025.

13           (2) Any documentation related to the imple-  
14 mentation of Executive Order 14159, Executive  
15 Order 14169, Executive Order 14162, Executive  
16 Order 14154, Executive Order 14151, Executive  
17 Order 14168, Executive Order 14182, and Office of  
18 Management and Budget Memorandum M-25-13 at  
19 the Department.

20           (3) Any documentation related to the evaluation  
21 of potential risks to domestic preparedness and col-  
22 lective response to terrorism or the Department's cy-  
23 bersecurity activities related to directives con-  
24 templated or ordered to pause Department grants,  
25 loans, or other financial assistance.

1           (4) Any documentation related to the evaluation  
2           of potential risks to domestic preparedness and col-  
3           lective response to terrorism or the Department of  
4           Homeland Security's cybersecurity activities related  
5           to the Department's implementation of Executive  
6           Order 14159, Executive Order 14169, Executive  
7           Order 14162, Executive Order 14154, Executive  
8           Order 14151, Executive Order 14168, Executive  
9           Order 14182, and Office of Management and Budget  
10          Memorandum M-25-13.

11          (5) Any documentation related to communica-  
12          tions with organizations outside the Department re-  
13          lated to the pause of Department grants, loans, or  
14          other financial assistance.

15          (6) Any documentation related to communica-  
16          tions with organizations outside the Department re-  
17          lated to the implementation Executive Order 14159,  
18          Executive Order 14169, Executive Order 14162, Ex-  
19          ecutive Order 14154, Executive Order 14151, Exec-  
20          utive Order 14168, Executive Order 14182, and Of-  
21          fice of Management and Budget Memorandum M-  
22          25-13 at the Department.
