COMMITTEE ACTION

September 26, 2024

The Committee on Homeland Security met, pursuant to notice, in open markup session, a quorum being present, on Wednesday, September 25, 2024, at 10:00 a.m. EDT in 310 Cannon to consider the following measures:

H.R. 3169, (Mr. Gimenez), to require the inspection of certain foreign cranes before use at a United States port, and for other purposes; the “Port Crane Security and Inspection Act of 2023”.

H.R. 3386, (Ms. Porter), to amend the Bottles and Breastfeeding Equipment Screening Act to require hygienic handling of breast milk and baby formula by security screening personnel of the Transportation Security Administration and personnel of private security companies providing security screening, and for other purposes; the “Bottles and Breastfeeding Equipment Screening Enhancement Act”.

H.R. 4406, (Mr. Correa), to require reporting accreditation of basic training programs of the Department of Homeland Security, and for other purposes; the “DHS Basic Training Accreditation Improvement Act of 2023”.

H.R. 5729, (Mr. Pfluger), to prohibit the use of Federal funds to establish a Homeland Intelligence Experts Group, and for other purposes.

H.R. 5840, (Mr. Graves of Louisiana), to require the Transportation Security Administration to streamline the enrollment processes for individuals applying for a Transportation Security Administration security threat assessment for certain programs, including the Transportation Worker Identification Credential and Hazardous Materials Endorsement Threat Assessment programs of the Administration, and for other purposes; the “Transportation Security Screening Modernization Act”.

H.R. 7311, (Mr. Guest), to amend the Homeland Security Act of 2002 to enhance the operations of U.S. Customs and Border Protection in foreign countries, and for other purposes; the “Combatting International Drug Trafficking and Human Smuggling Partnership Act of 2024”.

H.R. 7365, (Mr. Gosar), to provide PreCheck to certain severely injured or disabled veterans, and for other purposes; the “Veterans Expedited TSA Screening Safe Travel Act” or the “VETS Safe Travel Act”.

H.R. 8119, (Mr. Tony Gonzales of Texas), to establish in U.S. Customs and Border Protection a pilot program to adopt dogs from local animal shelters to be trained as therapy dogs, and for other purposes; the “Providing Emotional Assistance with Relief and Love Act” or the “PEARL Act”.

H.R. 9469, (Mr. Robert Garcia of California), to amend the Homeland Security Act of 2002 to codify the Transportation Security Administration’s responsibility relating to securing pipeline transportation and pipeline facilities against cybersecurity threats, acts of terrorism, and other nefarious acts that jeopardize the physical security or cybersecurity of pipelines, and for other purposes; the “Pipeline Security Act”.

H.R. 9668, (Mr. Strong), to establish in the Department of Homeland Security a working group relating to countering terrorist, cybersecurity, border and port security, and transportation security threats posed to the United States by the Chinese Communist Party, and for other purposes.

H.R. 9689, (Ms. Clarke), to amend the Homeland Security Act of 2002 to establish a DHS Cybersecurity Internship Program, and for other purposes.

H.R. 9722, (Mr. Higgins), to establish a pilot program to assess the use of technology to speed up and enhance the cargo inspection process at land ports of entry along the border; the “CATCH Fentanyl Act”.

H.R. 9731, (Ms. Greene of Georgia), to require the Secretary of Homeland Security to publish on a monthly basis the number of special interest aliens encountered attempting to unlawfully enter the United States, and for other purposes; the “Special Interest Alien Reporting Act of 2024”.

H.R. 9748, (Mr. D’Esposito), to require the Under Secretary of the Science and Technology Directorate of the Department of Homeland Security to develop a Departmentwide policy and process to safeguard research and development from unauthorized access to or disclosure of sensitive information in research and development acquisitions, and for other purposes; the “Research Security and Accountability in DHS Act”.

H.R. 9749, (Mr. Bishop of North Carolina), to amend the Homeland Security Act of 2002 to abolish the reorganization authority of the Department of Homeland Security, and for other purposes.

H.R. 9752, (Mr. LaLota), to require the homeland security southwest border threat assessment on Tren de Aragua and associated strategic plan, and for other purposes; the “Tren de Aragua Southwest Border Security Threat Assessment Act”.

H.R. 9762, (Mr. Menendez), to amend the Homeland Security Act of 2002 to provide explicit authority for the Secretary of Homeland Security and the Director of Cybersecurity and Infrastructure Security Agency to work with international partners on cybersecurity, and for other purposes; the “DHS International Cyber Partner Act of 2024”.

H.R. 9768, (Mr. Swalwell), to amend the Homeland Security Act of 2002 to establish within the Cybersecurity and Infrastructure Security Agency a Joint Cyber Defense Collaborative, and for other purposes; the “Joint Cyber Defense Collaborative Act”.

H.R. 9769, (Ms. Lee of Florida), to ensure the security and integrity of United States critical infrastructure by establishing an interagency task force and requiring a comprehensive report on the targeting of United States critical infrastructure by People’s Republic of China state-sponsored cyber actors, and for other purposes; the “Strengthening Cyber Resilience Against State-Sponsored Threats Act”.

H.R. 9770, (Mr. Green of Tennessee), to amend the Homeland Security Act of 2002 to provide for education and training programs and resources of the Cybersecurity and Infrastructure Security Agency of the Department of Homeland Security, and for other purposes; the “Cyber PIVOTT Act”.
