A BILL

To provide that no Federal funds made available to certain State Homeland Security Grant program recipients may be used to carry out any civil immigration enforcement activity, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protect World Cup
5 Attendees Act”.

1 **SEC. 2. LIMITATION ON USE OF FUNDS.**

2 (a) IN GENERAL.—Notwithstanding any other provi-
3 sion of law, an entity receiving Federal funds under sec-
4 tion 90005(a)(1)(B) or section 90005(a)(1)(C) of an Act
5 to provide for reconciliation pursuant to title II of H. Con.
6 Res. 14 (Public Law 119–21) may not, except under exi-
7 gent circumstances—

8 (1) participate in any program under section
9 287(g) of the Immigration and Nationality Act (8
10 U.S.C. 1357(g)), or

11 (2) carry out any civil immigration enforcement
12 activity under the immigration laws (as such term is
13 defined in section 101 of the Immigration and Na-
14 tionality Act (8 U.S.C. 1101)),
15 during the covered time period.

16 (b) DEFINITIONS.—In this section:

17 (1) COVERED TIME PERIOD.—The term “cov-
18 ered time period” means the period of time begin-
19 ning at 12:01 A.M. on June 11, 2026, and con-
20 cluding at 11:59 P.M. on July 19, 2026.

21 (2) EXIGENT CIRCUMSTANCES DEFINED.—The
22 term “exigent circumstances” means a situation in-
23 volving any of the following:

24 (A) The imminent risk of death, violence,
25 or physical harm to a person, including in the
26 case of terrorism (as such term is defined in

1 section 2 of the Homeland Security Act of 2002
2 (6 U.S.C. 101)).

3 (B) The imminent risk to the national se-
4 curity of the United States.

5 (C) The immediate arrest or hot pursuit of
6 an individual presenting an imminent risk to
7 public safety, including relating to death, vio-
8 lence, or physical harm to a person.

9 (D) The imminent risk of destruction of
10 evidence that is material to an ongoing criminal
11 case.
